Festive Outreach: On the Winter Solstice, our volunteers participated in the blessing-delivery activity of “Brilliant Hong Kong Delivers Blessings to All Households” to personally visit grassroots families across multiple districts and distribute festive blessing bags and care packages; on Mother’s Day, we co-organized the caring activity of “Filial Piety Love for

Mothers” to encourage citizens to write thank-you cards, promoting filial piety culture; during the Dragon Boat Festival, volunteers collaborated with the District Council members to launch the heartwarming zongzi charity campaign. Volunteers handmade over 150 love-filled zongzi and present them to grassroots residents; on the occasion of the Mid-Autumn Festival and National Day, the Company supported the citywide lantern riddle carnival of “Hong Kong Overflowing with Warmth” and joined over 12,000 participants in feeling the festive spirit, thus promoting Chinese culture while cultivating love and gratitude within the community.

Community Guardianship: We actively participated in the initiative of “Rat Busters 2.0 Program” to install “Rat Guards” for over 1,000 households in Wan Chai District; we also participated in the action of “Bidding Farewell to Subdivided Housing” campaign to provide onsite assistance to grassroots families in applying for transitional housing.

Emergency Relief: After the Wang Fuk Court fire incident in Tai Po District, we actively responded to Everbright Group’s coordinated emergency relief action. Together with Everbright Hong Kong and other Everbright enterprises stationed in Hong Kong in Hong Kong, we donated HK\$10 million for medical aid, supplies, temporary housing for affected families, and post-disaster reconstruction.
